Community Initiatives Fund

The Community Initiatives Fund is a Special Purpose Fund created by the Government of Saskatchewan through The Saskatchewan Gaming Corporation Act. CIF receives a portion of the net revenues from casinos Regina and Moose Jaw via the Saskatchewan Gaming Corporation and distributes those proceeds to support community-based projects throughout Saskatchewan. Since our establishment in 1995, we have distributed more than \$163 million to over 400 communities across the province. More than 10% of the province's population, primarily children and youth, benefit annually from CIF's support of these initiatives.

School Playground Equipment Grant (SPEG)

The School Playground Equipment Grant (SPEG) funded by the Government of Saskatchewan and administered by SPRA, helps schools across the province build safe, inclusive playgrounds. By offering up to \$50,000 in matching funds, the grant eases financial pressure on school councils and parent groups, accelerating local projects and expanding access to outdoor play. It reflects a commitment to vibrant, active communities and ensures more children have a place to play.

Co-op Community Spaces

Co-op Community Spaces has been developed to help protect, beautify and improve spaces across Western Canada. In keeping with our ongoing commitment to invest in the communities we serve, Co-op will contribute \$1 million to help support projects that improve the places Canadians meet, play, learn and share. Since 2015, 147 local projects have been supported with \$10.5 million dollars in capital funding.

The program is a partnership involving the Government of Saskatchewan, Sask Sport, SaskCulture and the Saskatchewan Parks and Recreation Association. Every year, these community grants help fund diverse programs and activities, such as youth beading programs, taekwondo clubs, music camps, hockey tournaments, Air Cadets, senior fitness classes, curling, swimming clubs and paint nights, to name just a few.

Dakota Dunes Community Development Corporation

The Dakota Dunes Community Development Corporation allocates grant funding in order to enhance independence and well being of residents of the communities we support, allocates these funds with fairness, accountability and transparency and supports economic development, social development, justice initiatives, educational development, recreation facilities operation and development, senior and youth programs, cultural development, community infrastructure development and maintenance, health initiatives, and other charitable purposes.

Community Development Corporations (CDC) Grants

You may apply to a CDC for funding if your organization is located in a community that is near a Saskatchewan casino. Applications are available for First Nations and non-First Nations groups. Recretional facilities operation & development, cultural development, community infrastructure development and maintenance are justsome areas that are considered for funding requests.

Battlefords Agency Tribal Chiefs (BATC) Community Development Corporation (CDC)

BATC Community Development Corporation will provide grants through support of catchment area projects for the development of healthy communities.

Northern Lights Community Development Corporation

The goals and objectives of the Northern Lights Community Development Corporation are "to facilitate the distribution of a portion of net proceeds derived from the Northern Lights Casino (or any successor thereof) located at the Peter Ballantyne Reserve No. 220, for charitable purposes to First Nations and Non-First Nations charities and organizations in the community in which the Corporation is located and in the surrounding areas.

Painted Hand Community Development Corporation

The Painted Hand Community Development Corporation invites applications from Charitable and Non Profit organizations for Yorkton Tribal Council and the cities of Yorkton, Melville and Secondary area for Economic

Development, Social Development, Community Infrastructure Development & Maintenance, Educational Development, Recreational facilities Operation & Development and much more.

Medavie Health Foundation Grant

Through Medavie Health Foundation, they are focused on partnering with community-based initiatives that promote long-term lasting impacts in support of healthy living, adolescent mental health, and families impacted by post-traumatic stress.
